It provides a full goal-based strategy combining active management with a focus on generating returns above the benchmark and exposure to additional sub asset classes such as hedge fund like strategies. It balances cost efficiency with flexibility, allowing for a dynamic approach to asset allocation and risk management to optimise long-term outcomes. It aims to achieve return from capital growth through a diversified portfolio of collective investment funds over the long-term.

The portfolio invests in a wide variety of assets, typically in equities, fixed interest, alternatives and money markets.

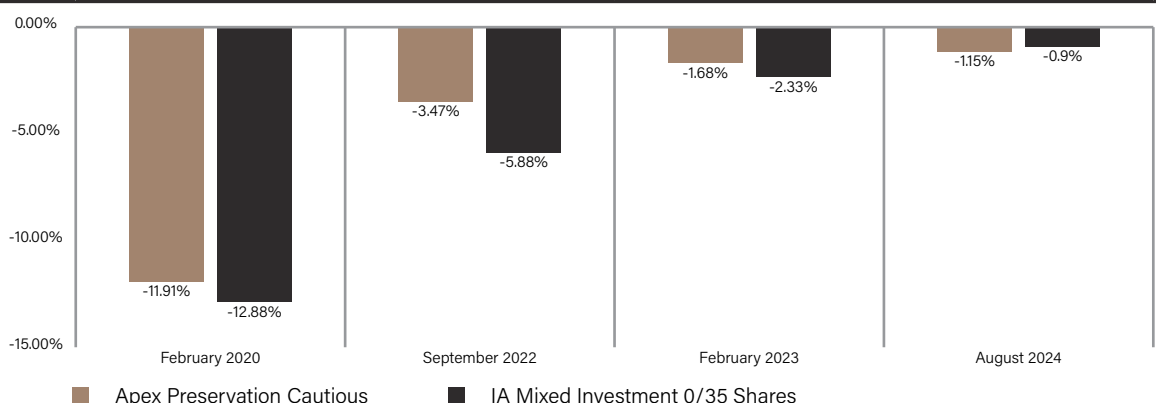

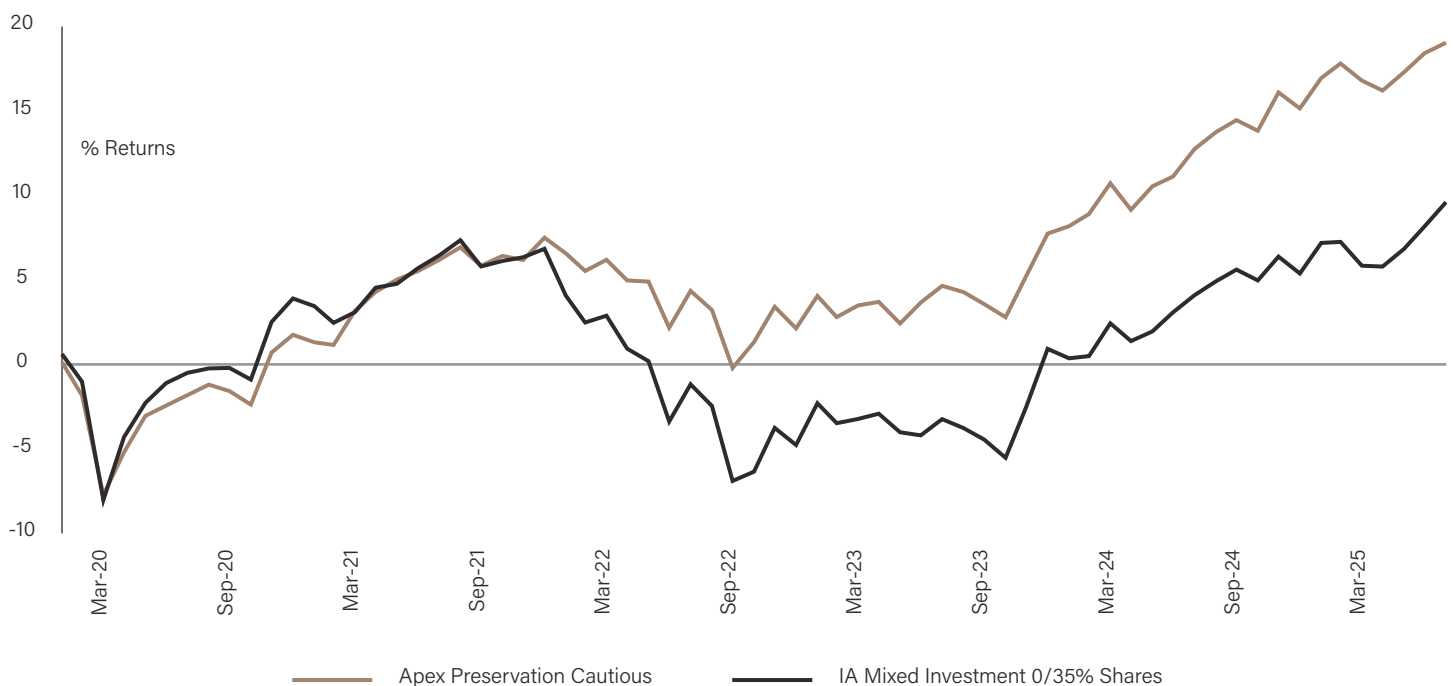
